5. ENTRY SYSTEM

All entries of athletes affiliated to the WMA are to be sent to the Masters National Association of their country. Entries will not be accepted without validation stamp. Entrants not affiliated to the WMA, may be accepted only with the approval of WMA. Entries must be accompanied by a photocopy of the participant's birth certificate or passport as proof of the athlete's date of birth.

6. DEADLINE FOR ENTRIES

1ST OF JUNE 2009. Late entries may be accepted but many may not get into Championships' official program. The late fee of extra 25€/event together with the late entry form must be returned to the organising committee no later than 16th of June 2009. No entries will be accepted after this.

7. PAYMENTS

Payments shall be made to the National Masters Association of your country by bank transfer no later than 20th of May 2009. You are asked to send attached copy of the payment together with the Entry Form.

8. DRUG TESTING

WMA will conduct drug / doping tests under the IAAF Procedural Guidelines for Doping Control ("PGDC"). Competitors must declare medication(s) being used when signing a doping control form. Any athlete using a prohibited substance in terms of the PGDC must apply for an exemption to the WMA Doping and Medical Committee.

If exemption is refused the prohibited substance(s) concerned may not be used and should you be selected for testing and test positive this will result in a suspension. (Please note that no medical certificate(s) will be accepted in substitution for an exemption certificate).

If you are granted an exemption certificate this must be produced at the Doping Control Centre if you are selected for a drug/doping test.

Details of prohibited substances and all Doping procedures are included in the Guidelines Booklet that is available from the IAAF, your affiliated IAAF Federation, and the IAAF website.

9. DISCLAIMER

I hereby accept my participation in these WMA Championships under the IAAF/WMA rules. Furthermore I relieve the organisers of any liability for any injury, loss or damage to myself or to my property that I may sustain in the course of the XVIII WMA World Masters Athletics Championships Stadia.

10. DRUG TESTING CONSENT
